Re: 2022 Premium Subsidy Confirmation for Eligible Retirees

Dear Member,

The Insurance Trust for Delta Retirees has received the 2022 subsidy amounts from Delta Air Lines, Inc., and this letter is to update you with that information.

The subsidy amounts and associated plan premiums listed on the "*Summary of Current Benefit Elections*" included in your enrollment packet in October, as noted, reflected the 2021 subsidy. In late December, you will receive your 2022 Benefits Confirmation Statement which will reflect the 2022 subsidy.

Below please find the 2022 subsidy figures. A 2022 premium and subsidy chart is also provided for your convenience on the following page.

Monthly subsidy amounts as provided by Delta Air Lines, Inc. on 10/29/2022:

The Subsidy applies to a closed group of both non-pilot and pilot retirees, and their respective spouses and survivors, under the agreement between Delta Air Lines, Inc. and the separate Section 1114 Committees representing retirees in Delta's 2005 bankruptcy.

To be eligible for a subsidy, a retiree, spouse, or survivor must meet **both** of the following qualifications:

- The Delta retiree's retirement date was January 1, 2006, or before, and
- The retiree, spouse, or survivor turned age 60 by January 1, 2007
