

2020 SUMMARY ANNUAL REPORT

For Insurance Trust for Delta Retirees, Inc. Benefit Plan

This is a summary of the annual report of the Insurance Trust for Delta Retirees, Inc. Benefit Plan, (the "Plan"), EIN 20-8503691, Plan No. 510, for period January 01, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The Plan has contracts with Anthem Blue Cross Blue Shield, Blue Cross Blue Shield Healthcare Plan of Georgia, Cigna Health and Life Insurance Company, Eyemed, Medco Containment Life Insurance Company and Metropolitan Life Insurance Company to pay health, dental, vision, prescription drug, PPO, indemnity and Medicare Advantage claims incurred under the terms of the Plan. The total premiums paid for the plan year ending December 31, 2020 were \$63,450,008.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the Plan, was \$28,309,112 as of December 31, 2020, compared to \$24,478,058 as of January 01, 2020. During the plan year, the Plan experienced an increase in its net assets of \$3,831,054. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the Plan had total income of \$70,098,331, including employee contributions of \$68,328,578, and earnings from investments of \$1,769,753 .

Plan expenses were \$66,267,277. These expenses included \$2,817,268 in administrative expenses, and \$63,450,009 in benefits paid to participants and beneficiaries.

There will be no copying charges for these portions of the report.
